



Software agreement between ZTE and Netgem - Partnership initiates in Mexico with TotalPlay

The partnership starts in Mexico with Fiber Operator TotalPlay; beginning in Q2'2017, ZTE will deliver to TotalPlay TV set-top boxes embedding Netgem middleware software. TotalPlay is one the fastest growing company in Mexico, that has deployed 50.000 km of fiber optic in more than 20 cities in Mexico, and provides unique double and triple play services to 600k subscribers.
